The promoter is: Sure (Guernsey) Limited, registered number 38694, whose registered office is at Centenary House, La Vrangue, St Peter Port, Guernsey GY1 2EY ("Sure").

No Third Party Endorsement

1. This competition is run by Sure and is in no way sponsored, endorsed or administered by, or associated with, Facebook, Twitter, Instagram or any other social network.

Entry

2. To enter this competition, entrants need to apply for tickets via the Sure (Guernsey) Limited website (www.sure.com), as stated in the competition social media post, stating the film they wish to see and the number of tickets they require (up to a maximum of 5 per applicant).
3. The closing date for entries is Thursday 27th August 2020.
4. All entries must be received by Sure by the time stated for the competition's closing on the relevant social media network. All entries received after this time will be automatically disqualified.
5. There is no entry fee for the competition. No purchase is necessary and no charge is applicable to entering the competition.
6. The competition is open to all Guernsey residents over the age of 13, unless otherwise stated.
7. Entrants under the age of 18 confirm, by entering the competition, that they have permission from their parent/legal guardian to do so.
8. By entering the competition, you are agreeing to be bound by these terms and conditions and any other applicable terms as stated in the initial competition social media post.
9. Sure's decision in respect of all matters to do with the competition will be final and no correspondence will be entered into.
10. Sure will not amend any entry or contact information once the entry has been received.
11. By entering the competition you agree that Sure may utilise and reproduce any associated social media content that you contribute.

Eligibility

 - a. automatically generated by a computer;
 - b. completed by third parties in bulk;
