

## Travel Data Bolt-ons Terms & Conditions

The Airtel Travel Data Bolt-ons Terms and Conditions should be read in conjunction with the Jersey Airtel Pay Monthly Mobile Terms and Conditions, the Jersey Airtel Consumer General Terms and Conditions and the Jersey Airtel Data Roaming Booster Terms and Conditions (which are available to view online at <https://www.sure.com/jersey/airtel/terms-and-conditions/>).

Where there is conflict between the Airtel Travel Data Bolt-ons Terms and Conditions and the General Jersey Airtel Pay Monthly Mobile Terms and Conditions, the Jersey Airtel Consumer General Terms and Conditions and the Jersey Airtel Data Roaming Booster Terms and Conditions, the specific Terms and Conditions from the Airtel Travel Data Bolt-ons shall apply, but all other provisions within the General Jersey Airtel Pay Monthly Mobile Terms and Conditions, the Jersey Airtel Consumer General Terms and Conditions and the Jersey Airtel Data Roaming Booster Terms and Conditions shall remain in full force and effect.

1. The Travel Data Bolt-ons are 'optional' and customers can choose to add onto their existing Pay Monthly account.

The Travel Data Bolt-ons are valid only in the following countries: **Albania**, Austria, **Belarus**, Belgium, **Bosnia & Herzegovina**, **Bulgaria**, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, **Iceland**, Ireland, Italy, Latvia, Lithuania, Luxembourg, **Macedonia**, Malta, Netherland, Poland, Portugal, Romania, **Serbia**, Slovakia, Slovenia, Spain, Sweden, **Turkey**, Switzerland, UK (inc Isle of Man), **Ukraine** and USA.

There are 3 bolt-on options with allowances.

- a. 1GB Data
- b. 3GB Data
- c. 5GB Data

Any usage outside the allowance or countries listed will be charged as per the Standard roaming rates on <https://www.sure.com/jersey/airtel/roaming-charges/>

2. No pro-rata charging will be applied. Charging starts from date of activation to the Customer's account.
3. The bolt-ons are only applicable for new and existing Pay Monthly Voice customers who have signed a 12 or 24 month contract, with a minimum of 3 months left on that contract, and are not available for Pay-As-You-Go Customers.
4. Once any of the bolt-ons are added onto the account, they cannot be removed and will remain on the account until contract end date. Upon contract renewal any these bolt-ons applied to the account will remain unless the customer specifies removal.
5. Jersey Airtel reserves the right to remove these bolt-ons at any time.
6. GST will be added in Jersey.
